The **Republic of Croatia and Bosnia and Herzegovina** have applied for financing in the amount of US\$ 6,776,256 equivalent from the World Bank toward the cost of the **Adriatic Sea Environmental Pollution Control Project I**, and it intends to apply part of the proceeds to payments for goods, works, related services and consulting services to be procured under this project. This project will be jointly financed by the national sources.

The project will include the following components:

#### Component 1

- (i) Turn key supply and installation of Solid waste leachate treatment plant to reduce the transfer of pollution to the Adriatic through karstic groundwater systems in Croatia;
- (ii) Turn key supply and installation of Solid waste leachate treatment lagoon to reduce the transfer of pollution to the sea through karstic groundwater systems and the Neretva River basin; and
- (iii) Supply of equipment to monitor coastal water quality.

#### Component 2

- (i) Consultant services for assessment of nutrient discharges in selected areas of Croatia's coast;
- (ii) Consultant services for Preliminary designs and project documentation, including preparation of tender documentation to access EU funds, for investments in wastewater and leachate treatment to comply with EU requirements in Croatia, and
- (iii) Consultant services for Preliminary designs and project documentation, including preparation of tender documentation to access EU funds, for investments in wastewater and solid waste leachate treatment to comply with EU requirements in Bosnia and Herzegovina.

Procurement of contracts financed by the World Bank will be conducted through the procedures as specified in the World Bank's [Guidelines: Procurement under IBRD Loans and IDA Credits](#) (current edition), and is open to all eligible bidders as defined in the guidelines. Consulting services will be selected in accordance with the World Bank's [Guidelines: Selection and Employment of Consultants by World Bank Borrowers](#) (current edition).

Specific procurement notices for contracts to be bid under the World Bank's international competitive bidding (ICB) procedures and for contracts for consultancy services will be announced, as they become available, in [UN Development Business](#) and [dgMarket](#) and the both official gazettes of the Croatia and Bosnia and Herzegovina.
