1. The Republic of Croatia *has received* financing from the World Bank toward the cost of the **Adriatic Sea Environmental Pollution Control Project I**, and intends to apply part of the proceeds for procurement of **Remediation works of landfill Sitnica with closed leachate system. CPV 454531000**

This invitation to bid follows the General Procurement Notice for this project appeared in Development Business, posted on 9 July 2013

2. **The Environmental Protection and Energy Efficiency Fund** as implementing agency, on behalf of **EKO d.o.o.** as Employer now invites sealed bids from eligible and qualified for **Remediation works of landfill Sitnica with closed leachate system.**

Project site is located west of the Blato and east of Potirne along road Vela Luka-Blato, on the edge of Blatsko polje. Landfill is located near to the tourist part of bay Karbuni and is located about 4 km from Blato and Vela Luka.

Waste is disposed on the site "Sitnica" since 1980, and landfill foreseen capacity of 95 000 t of waste. The total area of the existing landfill space that has been formed so far by disposing of waste is about 29 800 m², whereas a part of the existing landfill covers the plots that are not within the scope of the envisaged project.

Due to a specific position of the landfill (on the steep slope of natural terrain) and waste disposal method, the landfilled waste in some places is up to 40 m thick, forming a very steep slope with ratio 1:1.5 according to estimates, and as such may cause slipping and collapsing of the existing landfilled waste.

During the second half of 2016, a fire occurred at the landfill, which has **not been completely extinguished.** The Contractor is obliged to take all necessary protective measures during the transfer of waste, to prevent its spreading and protect a complete project site of further fire.

According to existing project documentation and permits, works on the landfill "Sitnica" will be done in the two (2) stages.

STAGE 1 – construction of ENTRY AND EXIT ZONE(traffic handling areas , the entrance door and partial fence around the scope, building for personnel, water supply (sanitary network), drainage system of potentially oily rainfall from the traffic handling

areas, the drainage system of waste sanitary water, weighbridge, garage for compactor, wheel washing facility)

STAGE 2 – construction of DISPOSAL CELLS, LANDFILL REMEDIATION, REHABILITATION OF EXISTING WASTE The second stage will be done in two (2) phases :

a. **phase 1 :**

- construction of disposal cells I, II, III and IV (including stormwater system, leached collection system, macadam road, reassignment of waste from the existing position to the new constructed disposal cells to the designed height, landscaping of the area
- closure of disposal cells I, II, III (cover sealing layer, degassing system and storm water drainage system from the landfill body)
- closure of the disposal cell field IV-A (cover sealing layer, intersealing layer, degassing system and storm water drainage system from the landfill body)

b. **phase 2 :** closure of the disposal cell IV-B. **Phase 2 is not in the scope of this works.**

The Contractors obligation is to prepare final inspection for issuance of the use permit:

1. First stage
2. Phase 1 of the second stage

The condition for issuance of the use permit of the phase 1 stage 2 is issued use permit for the first stage.

Complete works are as set out in Volume 2 and BoQ Volume 1 of the Bidding document

3. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's [*Guidelines: Procurement of grants by World Bank Borrowers January 2011, revised July 2014*](#) ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
4. A complete set of bidding documents in English language may be purchased by interested eligible bidders on the submission of a written application to the address below and upon payment of a nonrefundable fee of **1.500,00 HRK or equivalent in a convertible currency**. The method of payment will be a deposit or transfer to the specified account of the Environmental protection and Energy Protection and Energy Efficiency Fund.

The document will be sent upon receipt of a written application accompanied by appropriate evidence of payment of the non-refundable fee. Hard copy of documents will promptly be

dispatched by courier (on the bidders expenses); or can be collected by the Bidder, at the address below. However, no liability can be accepted for their loss or late delivery. Interested Bidders will be informed by e-mail after dispatching of documents. At the same time PDF version of document will be submitted. Bidders should note that the electronic PDF version of the bidding document would be issues solely to facilitate the preparation of the bid. In the event of any discrepancy between hard and electronic copies of the bidding documents, the hard copy will prevail.

A Pre-Bid meeting will take place, at **09:00 AM local time, June 28th 2017** at **Municipality Blato - town hall, Trg Franje Tuđmana 4, 20271 Blato, island Korčula**. A site visit conducted by the Employer shall be organized following the pre-bid meeting.

6. Bids must be delivered to the address below on or before **0900 AM Zagreb local time on August 1st, 2017**.

Electronic bidding will **not** be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below **on 0915 AM Zagreb local time on August 1st, 2017**.
7. All bids must be accompanied by a "*Bid Security*" of **500.000,00 HRK** or its equivalent in a freely convertible currency.
The bid security shall be an unconditional guarantee issued by a bank, using the Bid Security Form included in Section IV, Bidding Forms. The form must include the complete name of the Bidder. The bid security shall be valid for twenty-eight days (28) beyond the original validity period of the bid, or beyond any period of extension if required under ITB 18.2
